assume the risks of playing the 'Game'. I also hereby hold harmless the 'Sponsors' and the properties thereof, and indemnity	
them against any of all claims, actions, suits, procedures, costs, expenses, including, legal fees and expenses, damage and	
liabilities arising out of, connected with or resulting from my playing of the 'Game', including equipment. I hereby release	
the Sponsors and the property thereof from any and all such liability, and I understand that this release shall be binding upon
